The Ship

The charming *MPS Salvinia* is your floating hotel.

Your home for the week, the *MPS Salvinia*, is smaller and more nimble than many river cruise vessels, accessing rivers, waterways and locks that larger and longer ships cannot. The ship cruises through seven provinces and along rivers, canals, and seas, a one-of-a-kind itinerary featuring the full variety of waterways in the Netherlands.

Relax in style and comfort as glorious views of the Dutch landscape ease by. The *MPS Salvinia* bridge is open to passengers, allowing you to chat with the captain and observe the ship's navigation at close range. Other communal areas are found on the ship's three decks. The Observation Deck offers a lounge that opens onto the Sun Deck. The dining room and lobby are on the Promenade Deck. The whirlpool and sauna are found on the Main Deck. The decks connect by an elevator and stairs. Between the three decks, the welcoming staff, complimentary Wi-Fi, and the newly renovated ship, enjoy the amenities of the *MPS Salvinia*.

Passenger cabins are located on the Main and Promenade Decks. All double cabins are furnished with two single beds, one of which converts to a sofa during the day. Cabins also include en suite bathroom, a safe for your valuables, flatscreen TV, and individually controlled air-conditioning. Promenade Deck cabin windows are larger than those on the Main Deck. The cabins are comparable in size. All windows open to let fresh air into the cabins.

Throughout the cruise, enjoy a traditional Dutch menu. Early risers find freshly brewed coffee in the lounge before breakfast. Breakfast and lunch are buffet-style meals. Choose from fresh breads, local cheeses, eggs, and meats. Delicious three-course meals are served at dinner. Be prepared for the potato, a Dutch staple! Each day a new specialty is served. Try croquettes, herring, and other wonderful delicacies. Seating at meals is not pre assigned—use the opportunity to move around and make new friends.

Cruise Itinerary

April 9 – 18, 2026

9, Thursday Depart the US

Check in at the airport for the overnight flight across the Atlantic. (D in flight)

10, Friday Arrive Amsterdam, Utrecht, Board MPS *Salvinia* in Amsterdam

Welcome to the Netherlands! After going through passport control and customs, we meet our tour managers. We board the waiting motorcoaches and have a packed lunch onboard while we head to Utrecht. Here, we visit Castle de Haar, the largest castle in the Netherlands. Originally constructed in the late 14th century, the castle features extensive gardens similar to that of Versailles. We explore the grounds and, time permitting, enjoy a tour of the interior. Following, we return to Amsterdam where we board the *MPS Salvinia* and meet our crew for the week. Settle in and enjoy a Welcome Aboard dinner. (L, D)

11, Saturday Amsterdam, Kinderdijk, Arnhem, Doesburg

Following breakfast on board, we meet our local guides for a walking tour of Amsterdam, a must-see city with a rich history steeped in religion, art, engineering, and horticulture. After getting to know the capital, we start the drive to Kinderdijk. Enjoy a packed lunch on the way. Kinderdijk is a UNESCO World Heritage Site that features 19 working windmills. We watch a short film before visiting one of the windmills. After our visit, we meet the ship in Arnhem and have dinner on board as we sail to our port for the night, Doesburg. (B, L, D)

12, Sunday Zutphen, Kröller-Müller, Kampen

Over breakfast, we sail through the province of Gelderland, stopping in charming Zutphen, one of the oldest towns in the Netherlands. You have your choice of activities today. There is the option to attend a local morning church service, in Dutch, at a church in town. Enjoy coffee and fellowship for those who want to stay and enjoy lunch aboard. Enjoy scenic cruising on the IJssel River past Deventer and Zwolle into Kampen OR depart for the Kröller-Müller Museum directly following the church service. This national art gallery and sculpture park inspired Frederick Meijer Gardens in Grand Rapids, MI. Here, find the largest Van Gogh collection outside of the Van Gogh Museum and a stunning modern art sculpture park to peruse. Take in the park astride a bicycle available free of charge or stop in the museum's lovely shop and café for a bite to eat. A packed lunch is provided. We meet the rest of the group in Kampen this evening for an organ concert, followed by dinner. (B, L, D)



13, Monday Giethoorn, Dwingeloo, Sneek

After breakfast, travel by motorcoach to Giethoorn. Enjoy a boat ride through the canals of this village, famous for not allowing cars in the town. There is a brief stop to walk through the fairytalelike village and take in the parallel bridges down the canal. We continue to Dwingeloo to savor a group lunch together at a local restaurant, before reuniting with our ship in Sneek. With time to spare before dinner, browse the souvenir shops and street-side cafes. After dining, join the guided walk to the historic Water Gate and admire its reflection on the water. (B, L, D)

14, Tuesday Sloten, Hindeloopen, Harlingen, Franeker

Today we explore Friesland by motorcoach. In Sloten, Friesland's smallest city, the narrow streets and tiny houses bordering the canal make for terrific photos. The next stop is in charming Hindeloopen, a city with a rich arts and crafts history that is still evident today. Souvenir shop for all things Friesland related or pop into a café for a warm drink. Next, we continue to Harlingen to visit Friesland's only seaport. After time to explore and take in the sights, we head to Franeker to meet the ship. (B, L, D)

15, Wednesday Franeker, Scenic Cruising, Medemblik, Enkhuizen

The morning is free to visit Franeker. In the center of town is an amazing handmade 18th-century planetarium that still operates today. The Weigh House Museum, town hall, and the Gothic Martinikerk are also worth a visit. Lunch is served on board, as we cruise into the shallow Wadden Sea and through the locks to enter the IJsselmeer. The locks are part of the Enclosure Dike, a 20-mile-long dike built in the early 20th century to protect the many villages and towns around the Zuiderzee from flooding. We arrive in Medemblik, where we take a ride in army trucks into the tulip fields for the Tulip Liberation tour, immersing ourselves in history and learning about the harvesting of the flower's bulbs. We return to the ship for dinner and evening cruising to Enkhuizen. (B, L, D)

16, Thursday Enkhuizen, Zaandam

Our day begins in Enkhuizen, a picturesque historic fishing village. Much of the city's prosperity stems from its 17th-century herring trade. Both the Dutch East India Company and the West India Company had regional offices in Enkhuizen. Here, visit the Zuiderzee Museum, which details the region's rich maritime history. Following, we set sail for Zaandam while enjoying the scenery. With unique architecture and a plethora of shops, there is free time to explore this lovely, modern town where Claude Monet once lived and painted. Back aboard, we celebrate our week together at the Captain's Dinner. (B, L, D)

17, Friday Keukenhof, Amsterdam

Today we familiarize ourselves with the capital of the Netherlands through a canal cruise of Amsterdam. After seeing the city from a different perspective, we set off for the highlight of springtime in the Netherlands - the Keukenhof Gardens. The annual spectacle of color and creativity showcases the Netherlands' iconic tulips among others. Stroll through the themed gardens, greenhouses, and pavilions, plus enjoy a picnic lunch in the serene landscaping. The rest of the afternoon is at leisure to explore the vibrant streets of Amsterdam. In the evening, we return to our ship for a farewell dinner. (B, L, D)

18, Saturday Return

All too soon, it's time to say goodbye, or "*tot ziens*," to the Netherlands. We transfer back to Schiphol Airport for our return flights this morning. (B)

Belgium & France Extension

April 18 – 24, 2026

18, Saturday Brugge

For those of us joining the optional extension, we depart the *Salvinia* and board a motorcoach for the drive to Brugge, Belgium. Brugge is built on a system of canals and is considered one of the best-preserved medieval cities in Europe. We have free time to explore the city before an early evening hotel check-in followed by dinner. (B, D)

19, Sunday Brugge

This morning we take a guided tour of the city, including sights like the Market Square, Town Hall, and the massive 13th-century belfry. We stop at the Onze-Lieve Vrouwkerk to see the only piece of Michelangelo's work to have permanently left Italy: *Madonna and Child*. Our tour concludes at the Begijnhof. The remainder of the afternoon is at leisure until we meet for a group dinner. (B, D)

20, Monday Amiens, Caen

Depart Belgium this morning and head through the stunning countryside to France. Our first stop is in Amiens, famous for its 13th-century Gothic Cathedral. While here, we have time for exploration and an independent lunch. After our visit, we continue to Normandy and on to Caen. On arrival, we check into our hotel and share a group dinner. (B, D)

21, Tuesday Normandy Beaches, Caen

After breakfast, we begin our sightseeing of the Normandy Beaches. Our first stop is in St. Mere Eglise, the first French town liberated in WWII. It was near here that the U.S. 82nd and 101st Airborne Divisions were air-dropped to protect Utah Beach during the D-Day invasion. We continue to Utah Beach and the American Military Cemetery. Following, we return to Caen for an independent evening. (B, L)





22, Wednesday Versailles Palace, Paris

Today we visit Chateau de Versailles. As a symbol of the French monarchy during its peak, the famed castle was established in the early 17th century as a royal hunting lodge. Then we head into Paris and stop at Trocadero Gardens for views of the Eiffel Tower. We share dinner at a local restaurant, followed by an evening Seine River cruise. (B, D)

23, Thursday Paris

Our day begins with a panoramic motorcoach tour of Paris. We see the iconic Arc de Triomphe, Place de la Concorde, La Madeleine, and more. The afternoon is at leisure to discover all Paris has to offer. This evening we gather for a farewell dinner to conclude a wonderful tour. (B, D)

24, Friday Return

After breakfast, depart for Charles de Gaulle Airport for our return flights. (B)

General Data Protection Policy. We collect personal data, including, but not limited to legal name, gender, date of birth, passport information, dietary needs, and mobility concerns for the purpose of making travel arrangements on your behalf. We share this information with suppliers as it relates to the operation of your trip/tour. By signing the registration form/ agreeing to the terms in TRIP, you agree to sharing your personal data for the purpose of making travel agreements on your behalf.

The cost of your tour includes:

Air transportation on the main tour, roundtrip from Grand Rapids to Amsterdam, on the optional extension, Grand Rapids to Amsterdam returning from Paris to Grand Rapids, with any regularly scheduled air carrier, based on a nonrefundable/nonchangeable fare, which requires a minimum of 10 passengers traveling round trip together. The identity of the carrier, which may include the carrier's code-share partner, will be assigned and disclosed in your final documents. Tickets are issued 45 days prior to departure. All current airlines taxes, security fees and fuel surcharges are included. Note that these items cannot be guaranteed until tickets are issued.

Secure flight information. The requirement to collect date of birth, gender, and full name are federally mandated by the Transportation Security Administration's (TSA) Secure Flight Program. While disclosure of this information is voluntary, if it is not provided, participants may be denied boarding. TSA's privacy policy, as well as additional details, can be found at tsa.gov using the keywords Secure Flight. Witte takes all reasonable steps to safeguard the privacy of all information collected from its clients.

During registration, you may select an option to be considered for a \$100 discount off your tour cost, in lieu of earning airline frequent flyer miles. If available, a Witte team member will contact you before final payment to let you know you've been selected!

Frequent flyer points are not guaranteed in connection with group airfares. Some airlines may limit group airfare credits to 25% to 50% of the frequent flyer points that apply to individuals while others do not offer any credits for group airfares.

Surface transportation. Deluxe air-conditioned motorcoaches and on board the *MPS Salvinia*. Because motorcoach travel is restricted in many European cities, sightseeing is often done on foot or via public transportation.

Accommodations based on double occupancy and include private facilities. Promenade Deck supplement of \$300 per person. Shipboard accommodations in twin-berth cabins. First-class hotels on the optional extension. **Supplements for single occupancy are \$500 in a single cabin on the cruise and \$800 in a double cabin on the cruise, and \$400 on the optional extension.** If you register alone but want a roommate, we will do our best to assign one. Shared accommodation bed configurations vary by destination. Separate twin beds cannot be guaranteed. If a single room must be assigned to any member of the group for any reason, even if it is at the last minute or while on tour, we will need to charge the single supplement. Changes in rooming arrangements requested by the participant 45 or fewer days prior to departure may result in additional charges.

Meals. Upon embarkation, breakfast, lunch, and dinner with coffee or tea each day on the ship, except a picnic lunch on April 12th if attending Kröllér-Müller, and a picnic lunch on April 17th. Meals on the optional extension as noted in the itinerary. Meals on the extension do not include beverages.

Tour Personnel. Tour managers from arrival in Amsterdam until departure, and the ship's crew during the cruise. The tour managers may be assisted by local guides at key sites. Separate tour manager/driver on the optional extension.

Sightseeing and admission fees in accordance with the itinerary.

Tipping and taxes are included for all services, including tipping for the ship's crew, tour managers, and motorcoach drivers. Tipping is also included on the optional extension.

The tour cost does not include passports, airline luggage fees if charged, portage of luggage at airport and hotels that do not have porters, optional travel protection plan including luggage and trip cancellation coverage, optional excursions, independent meals, and any other items not mentioned as included.

For all traveling companions to benefit from the pre-existing condition waiver, each must enroll in travel protection within 21 days of initial deposit and meet qualifications for the pre-existing condition waiver.** The plan cost for the travel protection plan that applies to your tour will be noted in your brochure and on the registration form. Your carry-on bag must fit in the overhead compartment and have a maximum size of 42" (height + width + depth). Your personal item should be shaped and sized to fit under the seat in front of you in the aircraft. These size and weight restrictions conform to most airlines' requirements. Carry-on luggage does not fit in the overhead bins on the motorcoach. There may be room for it in the storage compartment under the coach or by an empty seat on board. If not, it will need to be placed on the floor in front of your feet. Portage of luggage is provided at the hotel to the greatest extent possible. Portage is not provided at airports and at hotels that do not have porters. Let your tour personnel know if you need assistance with your luggage.

Tour cost. The tour cost is based on a group of 86 passengers on the cruise, the Belgium & France extension is based on 25 passengers, and current tariffs for air and land arrangements. The tour cost is based on projected costs for 2026, and it may need to be repriced closer to departure. Witte Tours will make every effort to protect the price of this tour.

Please note that these travel arrangements are subject to possible price increases due to additional charges imposed by a supplier or government. You may be charged additional sums by Witte to offset increased fees, fuel surcharges, taxes, fluctuations in foreign exchange markets, and/or changes in group size. Before passing on an increase, Witte will use its best efforts to minimize the amount. If it is necessary to increase the tour cost, participants will be advised at final billing and provided with a summary of the contributing factors. Your signature on the registration form indicates consent to any post-purchase price increases.

Reservations and payments. To make reservations on this tour, complete the Registration Form and return it as indicated. Reservations cannot be accepted over the telephone. Payments are due as follows:

Deposit of \$450 per person with Registration Form.

Payment of \$1,250 per person by November 1, 2025.

Payment of \$1,250 per person by January 1, 2026.

Balance due on receipt of final invoice sent approximately 30 days prior to departure

If you are registering for the tour after one of the above payment dates, increase your deposit amount accordingly so your account will be up to date. Please note that checks returned due to insufficient funds are subject to a \$30 service fee.

Credit card payments. Visa, MasterCard, Discover or American Express credit cards are accepted for the deposit. The deposit charge is processed shortly after receipt of your registration form.

Cancellations and refunds. Witte must receive notice of cancellation in writing. Penalties are per person and will be based on the date of receipt, as follows:

The service fee noted under “Special Flight Arrangements” and the nonrefundable portion of any special arrangements, or any other non-refundable arrangements made on behalf of the canceling participant, are also added to the above penalties. Allow four to six weeks for processing of refunds. Note that payments made by check are refunded by check to the person or organization that made the payments, and payments charged to a credit card are credited back to the same credit card.

Membership/Passenger’s Responsibility. You acknowledge Witte is responsible for a comfortable and respectful atmosphere that protects the health of all travelers, creating a positive tour experience. This requires commitment from every individual on the tour to assume personal responsibility for protecting their own health and wellbeing, as well as the health and wellbeing of other travelers and tour personnel. You pledge to follow local and state laws as well as tour and sightseeing requirements related to any community health concern. If you refuse to comply with these rules of conduct, you understand that Witte Travel & Tours reserves the right to remove you from the trip and you are responsible for any associated expenses. Witte reserves the right to accept or reject any person as a member of the tour and to expel from the tour any participant whose conduct or condition is incompatible with the interest of the group.

Land-only participants. If you wish to make your own flight arrangements, contact Witte for the land-only cost at least 90 days prior to departure. Participants who make their own flight arrangements are strongly encouraged to coordinate their flight schedules with the group’s flight schedule and to use the same airports. The group’s airport transfers on the arrival and return days will be timed to the group’s flight schedule. Land-only participants may need to arrange for their own airport transfers. Contact Witte for information and costs on options for private transfers. Witte cannot be responsible for any inconveniences to land-only participants resulting from changes in the group’s flight schedule. Participants who change their status to land-only less than 90 days prior to departure may be subject to penalties imposed by the airlines.

Domestic flight connections. Note on your registration form if you would like to fly to and from the international departure city. You will be contacted with schedule options and costs. Witte must receive requests for connecting flights at least 45 days prior to departure.

Special flight arrangements. Note on your registration form if you would like to extend your stay and/or depart from and/or return to another city. The number of passengers who can deviate from the group’s flight schedule is restricted. You will be contacted to let you know if the arrangements you requested are possible and to advise you of schedule options and costs. Upon confirmation of your special arrangements, a nonrefundable service fee of \$75 per person will be added to your account along with any additional air or land costs that may apply. In the event of cancellation, the service fee and any nonrefundable portion of special air or land arrangements made for you will be added to the penalties noted under “Cancellations and Refunds.” Witte must receive requests for special flight arrangements at least 45 days prior to departure.

Special meal requests and food allergies. Note special meal requests and food allergies on your registration form. Witte cannot be responsible if special requests are not met but we will pass them on to the airlines, hotels and restaurants. If you have dietary restrictions or food allergies, be sure to carry your medications with you at all times. Also, discuss your special needs with your tour personnel and ask the wait staff about the foods you are served.

Mobility Concerns. Sightseeing on Witte tours almost always includes walking. Visits to historical places often mean climbing stairs and walking on uneven surfaces or cobblestones. The Americans with Disabilities Act (“ADA”) is only applicable within the U.S., and facilities for disabled individuals are limited outside its borders. A qualified and physically able companion must accompany travelers who need such assistance. Motorized scooters and wheelchairs are unsuitable for many trips. Transportation services, including many tour motor coaches, are not equipped with wheelchair ramps. Handicap accessibility is not always available. Witte tour personnel are not able to provide attendant services.

Time away from the tour. Advise Witte in writing at least 45 days before departure if you plan to spend some time away from the tour. Wherever possible, you will be credited for missed hotel nights.

Final tour documents—including itinerary, hotel list, passenger list, flight schedules with departure instructions, and luggage tags—are sent about 10 days prior to departure. Flight tickets are usually made available at the airport at check-in.
